2. **Processes of Health Care Delivery in the PICU:** Improved understanding of the human and matériel resources used within the PICU (including health technology assessment) and elucidation of any potential association with outcomes of care.
3. **Outcomes of Pediatric Critical Care:** Assessment of the end-result of the care provided in the PICU and the factors associated with such outcomes.
